- 2. Pledge of Allegiance was given.
- 3. Additions to the Agenda, item 13. Planning Commission request for update of the Zoning Ordinance, Treasurer's Report was removed. Item 10. Sexton Position was removed, Consumer's Energy was added to Correspondence. Public Comment was added as number 9. The rest of the Agenda was amended to add number 9. Public Comment. Motion to approve the Agenda was made by Ms. Lawry and supported by Mr. Campbell. Motion Carried.
- 4. Approval of Minutes of August 14,2018. Motion to approve the Minutes as presented was made by Mr. Green and supported by Treasurer Goschka. Motion Carried.
- 5. Approval of Special Meeting Minutes of August September 6, 2018. Motion to approve the Minutes as presented was made by Mrs. Schultz and supported by Mr. Green. Motion Carried.
- 6. Treasurer's Report will be on the Agenda for next Month.
- 7. Bills to be Paid were approved in a Motion made by Mrs. Campbell and supported by Ms. Lawry. Motion Carried.

quotes on revising and updating the current Zoning Ordinance. Motion was made by Mrs. Goschka ad supported by Mr. Green to get quotes and move ahead with the updating and revision. Motion Carried.
