### BUILDING PERMITS

Building permits are required for new home construction, home repairs, remodeling, pond construction, pole barns, decks, etc. A building permit is required to promote and safeguard the public health, safety, and general welfare of the community. If you are unsure whether or not a permit is required, please contact our Building Inspector, Tom Westfall at 517-881-4654.

Demolition permits are required for removal of structures.

Prior to applying for a permit for an outside addition or new construction, you must have approval from the Eaton-Barry Health Department, Environmental Health Unit. Their telephone number is 517-541-2615.

### RECYCLING/COMPOST GRAND LEDGE RECYCLING:

The recycling center is open to all patrons and there is no charge to enter. Please be sure that all materials have been cleaned and are sorted appropriately.

The center is located in Grand Ledge at 401 Whitney Street behind Oakwood Cemetery. The recycling center is open Wednesdays from 3:00 - 7:00 p.m. and Saturdays from 8:00 a.m. - 4:00 p.m. with an attendant on duty.

All Eaton County residents are welcome to recycle at any Eaton County Recycling Center. Delta Township Hours: Tues: 8 a.m.-4 p.m., Wed: 12-6 p.m., Sat: 8 a.m.-4 p.m. - located at: 5717 Millett Hwy, Lansing, MI

### GRAND LEDGE COMPOST:

Use of the compost center is available to City of Grand Ledge and Oneida Township residents. An annual pass (good for the calendar year) in the form of a windshield sticker is required for entry. The annual pass is available at Grand Ledge City Hall (cash or check only), passes are no longer being sold on site at the compost center. Proof of residency is required in the form of a picture ID, along with either a voter ID card, property tax notice/receipt, or City of Grand Ledge water/sewer bill. An applicant may purchase a maximum of two annual passes.

**Oneida Township Residents** may purchase a compost center annual pass for \$125.00

### TOWNSHIP CEMETERIES

Oneida Charter Township maintains three cemeteries.

- Union Cemetery- Benton Rd. 1/2 mile south of Eaton Hwy.
- Pioneer Cemetery- Hartel Rd. 1/2 mile south of Mt. Hope Hwy.
- Strange Cemetery- Oneida Rd. 1/4 mile south of Strange Hwy.

Residents may purchase a gravesite for \$200.00, nonresidents \$500.00. Please see our website for cemetery regulations.
