**DOG LICENSES**

All dogs four months or older must be licensed by Eaton County Animal Control. Dog licenses may be purchased at the Township office during normal business hours through February 28, 2018. After February 28, they will need to be purchased through Eaton County.

When purchasing a license, you must provide:

**--A copy of the dog's current rabies certificate.**

**--Proof that your dog was neutered or spayed.**

## BUILDING PERMITS

Building permits are required for new home construction, home remodeling including finishing basements, decks, pole barns, pools, etc. Building permits are required to promote and safeguard the public health, safety and general welfare of the community. Prior to applying for a building permit that expands the exterior dimensions of your home or the building of an auxiliary structure, you must have approval from the Eaton-Barry

Health Department, (517) 541-2615.

## BUILDING INSPECTIONS

The State of Michigan suggests the Township Assessor visit 20% of Township properties every year. The Assessor will interview you, take measurements of all structures, observe the physical characteristics of the property and take a digital picture of all structures. Approximately 90% of the properties have been inspected. It is anticipated that the remaining inspections will be completed during 2018. If you have questions, please contact Don Cooley, Assessor.
