***FOOTNOTE:** Water Closets, Laundry Tray, Bidet, Urinal, Floor Drain, Bathtubs, Sink (any description), Emergency Eye Wash, Roof Drain, Lavatories, Emergency Shower, Refrigerator, Grease Trap, Shower Stall, Garbage Grinder, Washing Machine, Water Softener, Slop Sink, Ice Making Machine, Sprinkler System (irrigation), Dishwasher, Water Connected to Carbonated Beverage Dispenser, PLUS ANY OTHER FIXTURE, DRAIN OR WATER CONNECTED APPLICANE NOT LISTED.

General: Plumbing work shall not be started until the application for permit has been filed. All installations shall be in conformance with the Plumbing code. No work shall be concealed until it has been inspected. When ready for an inspection call the above number providing as much advanced notice as possible. The inspector will need the job location and permit number.

Expiration of Permit: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work.

A permit will be canceled when no inspections are requested and conducted within six months of the date of issuance or the date of a previous inspection. Canceled permits cannot be refunded or reinstated.
