- 2. Pledge of Allegiance was given.
- 3. Additions to the Agenda. Item 14, Sheriff's Contract was added. Motion to approve the Agenda was made by Melissa Goschka and supported by Jim Green. Motion Carried.
- 4. Approval of Minutes of September 11, 2018. Motion to approve the Minutes as presented was made by Jim Green and supported by Melissa Goschka. Motion Carried.

- 6. Bills to be Paid was presented by Melissa Goschka. Melissa pointed out the payment to Lansing Ice and Fuel in the amount of \$1,598.00 is prepayment for this winter's heating bill.
